 - c. water plant nos. 1, 2, and 4 ground storage tank alternate fill line installation;
 - d. disinfection system upgrades at water plant nos. 1, 2, 3 and 4;
 - e. capital improvement plan;
 - f. discuss potential pocket park near Mason Creek hike and bike trail;
 - g. risk and resilience assessment; and
 - h. potential winterization improvements.
8. Report on West Memorial Municipal Utility District Sewage Treatment Plant meeting and proposed plant improvements.
