

NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 81 OF HARRIS COUNTY, TEXAS

The Board of Directors of Harris County Municipal Utility District No. 81 of Harris County, Texas, will hold a regular meeting on Thursday, March 26, 2026, at 6:00 p.m., at 805 Hidden Canyon, Katy, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
4. Report from Revenue Management Services on businesses paying sales tax.
5. Financial and bookkeeping matters, including payment of the bills and review of investments.
6. Operation of District facilities, including:
 - a. billings, repairs, maintenance, and customer requests;
 - b. sanitary sewer line(s) near Kenlake Drive, and draft agreement with Cornerstones Municipal Utility District regarding same;
 - c. evaluation of District's interconnects and related recommendations;
 - d. odor control options for lift station(s), including related agreement(s) or proposal(s) and lift station fence proposal;
 - e. review proposals for maintenance of District facilities and authorize appropriate action;
 - f. conduct annual review of Drought Contingency Plan;
 - g. review Water Conservation Plan and authorize submittal to the Texas Water Development Board;
 - h. review Critical Load Spreadsheet for District's facilities and authorize annual filing; and
 - i. approve and authorize operator to file water loss audit.
7. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
8. Engineer's report on District facilities, including:
 - a. Capital Improvement Plan;
 - b. Park York force main replacement, including easement acquisitions and related approvals;
 - c. water plant no. 3 elevated storage tank rehabilitation;
 - d. Harris County Memorial Parkway storm sewer and drainage facility improvements, including additional detention/mitigation;
 - e. sanitary sewer rehabilitation for Memorial Parkway, Sections 3, 4 and 5;
 - f. sanitary sewer rehabilitation for Cimarron Subdivision, Sections 1, 2, and 3 and Memorial Parkway, Sections 6, 7, and 8;
