CINCO REGIONAL SEWAGE TREATMENT PLANT

The Board of Directors of Harris County Municipal Utility District No. 81 of Harris County, Texas, will hold a special meeting on Thursday, May 15, 2025, at 6:00 p.m., at 805 Hidden Canyon, Katy, Texas, to discuss and, if appropriate, act upon the following items:

1. Approve minutes.
2. Financial and bookkeeping matters, including payment of the bills and review of investment of Cinco Plant funds.
3. Cinco Plant operations, discharge, repairs and maintenance.
4. Receive report of engineer, including:
  - a. discuss 2025 Plant Capital Improvement Plan;
  - b. approve plans and specifications and authorize advertisement for bids for trunk line manhole rehabilitation, Phases 1-3;
  - c. approve proposals, plans, and specifications and authorize advertisement for bids for Plant electrical improvements and generator replacement;
  - d. pay estimates, change orders, substantial completion and final acceptance for trunk line sanitary sewer manhole rehabilitation, Phase 4;
  - e. pay estimates, change orders, substantial completion and final acceptance for trunk line sanitary sewer rehabilitation, Phases 5 and 7, including emergency repairs for collapsed line;
  - f. approve plans and specifications and authorize advertisement for bids for replacement of access road bridge wingwall and waterline repairs;
  - g. Cinco Municipal Utility District No. 1 effluent reuse system, including update on construction of reclaimed water facilities; and
  - h. water sources for Plant operations, including interconnect to Cinco Municipal Utility District No. 1 water line and agreement amendment related to same.
5. Sanitary sewer rehabilitation for Memorial Parkway, Sections 3, 4, and 5 District project, including pay estimates, contract, and contractor matters.
