### HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 81 OF HARRIS COUNTY, TEXAS


The Board of Directors of Harris County Municipal Utility District No. 81 of Harris County, Texas, will hold a regular meeting on Thursday, May 22, 2025, at 6:00 p.m., at 805 Hidden Canyon, Katy, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Renewal of District's insurance policies.
4. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
5. Report from Revenue Management Services on businesses paying sales tax.
6. Financial and bookkeeping matters, including:
  - a. payment of the bills, review of investments;
  - b. adopt Resolution Expressing Intent to Reimburse; and
  - c. Travel Reimbursement Guidelines and Director Expenses for the Association of Water Board Directors summer conference.
7. Operation of District facilities, including billings, repairs, maintenance, and customer requests, including:
  - a. lift station generator proposals;
  - b. sanitary sewer line(s) near Kenlake Drive, and draft agreement with Cornerstones Municipal Utility District regarding same; and
  - c. evaluation of District's interconnects and related recommendations.
8. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
9. Engineer's report on District facilities, including:
  - a. Capital Improvement Plan;
  - b. GIS updates;
  - c. Park York force main replacement, including update on easement acquisition;
  - d. water plant no. 3 elevated storage tank rehabilitation;
  - e. Harris County Memorial Parkway storm sewer and drainage facility improvements, including additional detention/mitigation;
  - f. sanitary sewer rehabilitation for Memorial Parkway, Sections 3, 4 and 5;
  - g. sanitary sewer rehabilitation for Cimarron Subdivision, Sections 1, 2, and 3 and Memorial Parkway, Sections 6, 7, and 8;
