

## NOTICE OF MEETING

### HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 81 OF HARRIS COUNTY, TEXAS

The Board of Directors of Harris County Municipal Utility District No. 81 of Harris County, Texas, will hold a regular meeting on **Thursday, June 27, 2019, at 6:00 p.m.**, at 805 Hidden Canyon, Katy, Texas, to discuss and, if appropriate, act upon the following items:

1. Approve minutes.
2. Tax assessment and collections matters, including delinquent tax collections, installment agreements, payment of tax bills, and update from SRI on businesses paying sales tax.
3. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.
4. Financial and bookkeeping matters, including payment of the bills and review of investments and community projects.
5. Discuss Association of Water Board Directors summer conference, approve reimbursement of eligible expenses, and authorize attendance at winter conference.
6. Operation of District facilities, billings, repairs, and maintenance, including:
  - a. update on customer requests;
  - b. Park Meadow sanitary sewer line repairs;
  - c. report on review of interconnects; and
  - d. report on water plant no. 2 storm sewer investigation.
7. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
8. Engineer's report on District facilities, including:
  - a. approve plans and specifications and authorize advertisement for bids for water plant no. 4 natural gas generator and motor control center replacement;
  - b. replacement of booster pumps and motors at water plant no. 4;
  - c. approve pay estimates, change orders, substantial completion, and final acceptance for Park Bend and Strawberry Park storm sewer inlet improvements;
  - d. televising of Cimarron Subdivision, Sections 1 and 2;
  - e. Harris County Precinct 3 extension of the hike and bike trail west of Mason Road;
  - f. capital improvement plan;
  - g. update on bond application no. 8; and
  - h. other engineering matters.
