

## NOTICE OF MEETING

### HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 81 OF HARRIS COUNTY, TEXAS


The Board of Directors of Harris County Municipal Utility District No. 81 of Harris County, Texas, will hold a regular meeting on Thursday, August 25, 2022, at 6:00 p.m., at 805 Hidden Canyon, Katy, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Approve minutes.
3. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
4. Approve Depository Pledge Agreement with Frost Bank.
5. Report from Revenue Management Services on businesses paying sales tax.
6. Financial and bookkeeping matters, including payment of the bills, review of investments, and community projects.

  - b. Memorial Parkway, Sections 3, 4, and 5 sanitary sewer line rehabilitation;
  - c. Park York force main relocation;
  - d. water plant no. 2 well rehabilitation;
  - e. water well no. 1 investigation;
  - f. Harris County storm sewer and drainage facility improvements, including additional detention/mitigation;
  - g. water plant nos. 1, 2, and 4 ground storage tank alternate fill line installation;
  - h. water plant no. 2 generator replacement; and
  - i. update on bond application no. 9.
10. Cinco Municipal Utility District No. 1 effluent reuse system, including legal conflict waiver, Third Amendment to Reclaimed Water Agreement, and Third Supplement to side letter agreement.
