

#### CINCO REGIONAL SEWAGE TREATMENT PLANT

The Board of Directors of Harris County Municipal Utility District No. 81 of Harris County, Texas, will hold a special meeting on Thursday, September 19, 2024, at 6:00 p.m., at 805 Hidden Canyon, Katy, Texas, to discuss and, if appropriate, act upon the following items:

1. Approve minutes.
2. Financial and bookkeeping matters, including payment of the bills, and review of investment of Cinco Plant funds.
3. Cinco Plant operations, discharge, repairs and maintenance, including update on RAS sludge pump no. 3 replacement.
4. Receive report of Engineer, including:
  - a. discuss 2024 Plant Capital Improvement Plan;
  - b. authorize design of trunk line manhole rehabilitation, Phases 1-3;
  - c. approve plans and specifications and authorize advertisement for bids for Plant electrical improvements and generator replacement;
  - d. pay estimates, change orders, substantial completion and final acceptance for trunk line sanitary sewer manhole rehabilitation, Phase 4;
  - e. approve plans and specifications and authorize advertisement for bids for trunk line sanitary sewer manhole rehabilitation, Phases 5 and 7;
  - f. pay estimates, change orders, substantial completion and final acceptance for trunk line sanitary sewer rehabilitation, Phases 5 and 7, including emergency repairs for collapsed line;
  - g. approve plans and specifications and authorize advertisement for bids for repairs to access road bridge wingwall and waterline repairs;
  - h. Cinco Municipal Utility District No. 1 effluent reuse system, including update on construction of reclaimed water facilities; and
  - i. approve survey proposal(s).
