 - b. report on Harris County storm sewer and drainage facility improvements;
 - c. water plant nos. 1, 2, and 4 ground storage tank alternate fill line installation;
 - d. disinfection system upgrades at water plant nos. 1, 2, 3 and 4;
 - e. capital improvement plan;
 - f. emergency repairs to sanitary sewer manhole; and
 - g. other engineering matters.

11. Second Amendment to the Reclaimed Water Agreement, Second Supplement to the Side Letter.
