1. Public comments.
2. Approve minutes.
3. Tax assessment and collections matters, including delinquent tax collections, installment agreements, payment of tax bills, and update from SRI on businesses paying sales tax.
4. Financial and bookkeeping matters, including payment of the bills, and review of investments and community projects.

 - b. report on Harris County storm sewer and drainage facility improvements;
 - c. water plant nos. 1, 2, and 4 ground storage tank alternate fill line installation;
 - d. disinfection system upgrades at water plant nos. 1, 2, 3 and 4;
 - e. capital improvement plan;
 - f. discuss potential pocket park near Mason Creek hike and bike trail; and
 - g. other engineering matters.
10. Report on West Memorial Municipal Utility District Sewage Treatment Plant meeting and proposed plant improvements.
11. Operation, repair, maintenance, and rental of Administrative Office and District website and employment matters, including:
 - a. security camera and equipment maintenance and related proposals; and
 - b. sprinkler system analysis.
