

CINCO REGIONAL SEWAGE TREATMENT PLANT

The Board of Directors of Harris County Municipal Utility District No. 81 of Harris County, Texas, will hold a special meeting on Thursday, November 21, 2024, at 6:00 p.m., at 805 Hidden Canyon, Katy, Texas, to discuss and, if appropriate, act upon the following items:

1. Approve minutes.
2. Financial and bookkeeping matters, including:
 - a. payment of the bills and review of investment of Cinco Plant funds; and
 - b. adopt budget for fiscal year end December 31, 2025.
3. Cinco Plant operations, discharge, repairs and maintenance, including water pump replacement.
4. Receive report of engineer, including:
 - a. discuss 2024 Plant Capital Improvement Plan;
 - b. approve plans and specifications and authorize advertisement for bids for trunk line manhole rehabilitation, Phases 1-3;
 - c. approve proposals, plans, and specifications and authorize advertisement for bids for Plant electrical improvements and generator replacement;
 - d. pay estimates, change orders, substantial completion and final acceptance for trunk line sanitary sewer manhole rehabilitation, Phase 4;
 - e. review bids and award contract for trunk line sanitary sewer manhole rehabilitation, Phases 5 and 7;
 - f. pay estimates, change orders, substantial completion and final acceptance for trunk line sanitary sewer rehabilitation, Phases 5 and 7, including emergency repairs for collapsed line;
 - g. approve plans and specifications and authorize advertisement for bids for replacement of access road bridge wingwall and waterline repairs; and
 - h. Cinco Municipal Utility District No. 1 effluent reuse system, including update on construction of reclaimed water facilities.
